

During the Model "A" era, cosmetics were reminiscent of some of our more recent styles and affectations. Lipstick was bright red, put on in a coupid's bow. Eyebrows were often plucked to thin arches and lines were drawn around the eyes. False eyelashes were not worn during the Model A era. Bright nail polish with "moons" at the cuticle was popular and rouge was a necessary item of the time.

Costume jewelry was in abundance for women and was intended to coordinate with the dress. Multistringed beads of the twenties gave way to wrought metal necklaces and bracelets set with mock jewels. Earrings might be either the large button type or dangling.

Men wore cuff links and a few still wore fob watches, since wrist watches had not become popular at this time.

Eye glasses were distinguished. Many were rimless and might be held by pince-nez levers. Some women used lorgnettes for evening and some had folding spectacles on chains.

Women carried feathery fans in the evening and men often carreid canes.

Joe showed proper trimming of padding, alignment and use of hog rings and tacks to complete the job in about 20 minutes. Questions were kept to a minimum during this time since Joe had a mouthful of tacks with which to work.

In finishing the seminar topics, Joe gave valuable hints in preparing your finished upholstering for judging. 

(b) delete: membership card, now reads: SPOUSES. If member is married, spouse receives right to vote. (c) delete: will receive a membership card. Now reads: FAMILY MEMBERSHIP shall be issued to the immediate members of a family of an active member. A family member must be of the same household as the active member. A family member will not receive the DISTRIBUTOR. but has the right to vote, if over the age of eighteen years. ARTICLE V, SECTION 1. Delete: appointed by the President. Now reads: THE ELECTION CHAIRMAN SHALL be the most recent Past-President. His duties shall be to accept nominations and notify all candidates, draw up, mail, receive and talley ballots. Delete: (b) All members in good standing and over

the age of eighteen years shall be eligible to run for office. ARTICLE VI, SECTION 2, Delete: THE OFFICERS. Now reads: BOARD OF DIRECTORS shall consist of the President, Vice-President, Secretary, Treasurer, Round-Up Chairman, Technical Advisor and Editor (appointive office). Add: (a) All members in good standing and over the age of eighteen years shall be eligible to run for office. SECTION 3, Substitute: BOARD OF DIRECTORS for word, OFFICERS. SECTION 7, TREASURER. The Treasurer shall have charge and custody and be responsible for all funds current mailing address of members and perform general duties incident to the office of Treasurer, and be present at the annual audit. SECTION 9, TECHNICAL ADVISOR. His duties are to write articles for the paper, maintain a record of all club books, tools, etc. Perform all duties incident to the office of Technical Advisor and arrange the technical seminars and general meeting programs. SECTION 11, Substitute: BOARD OF DIRECTORS for word OFFICER. ARTICLE VIII, SECTION 2 (a) Delete: entire paragraph: an expenditure over \$75.00 must first be presented to the general membership for approval, with the following exceptions, that being the yearly rent on the club house and clubsponsored events. ARTICLE IX, SECTION 1. When the club treasury is transferred from one Board to another, or the treasurer is replaced, the books must be audited by an auditing committee appointed by the President and approved by the Board of Directors.
