

Let's get these last two positions fill by the February 10 meeting, but to do that, you will need to step forward and volunteer.

Regarding the Adult Christmas
Party, I contacted the Foxfire Restaurant and was informed that the
December 3 and 17 dates had been
booked. I then contacted the new
Claim Jumper Restaurant in Fountain
Valley. They had been open only one
week and did not yet have any December bookings. I asked Dan and Val
Simmons to look the banquet room over,
and they reported that the room was
very nice, everything is new, with a
built-in bar-dance floor, and a private
entrance from the parking lot.

I called a Special Board of Directors meeting, which was held on January 14, after the Technical Seminar. The following items were resolved:

 The Adult Christmas Party location will be the Claim Jumper. A \$100.00 deposit will be made to secure the banquet room for December 10.

- 2. The Knott's Berry Farm Round-up contract requires that, on or before October 15, the club will pay to Knott's the contract balance, \$1,662.50. It was decided that this amount be taken from the General Treasury and placed into a Certificate of Deposit with Far Western Bank, until October 14, 1983.
- 3. Our regular checking account is non interest bearing, and B of A does not have an interest bearing checking account for businesses. Therefore, out regular checking account will be moved to Republic Savings and Loan, wherein we will be earning 5.25 to 10.00% interest, depending on our balance.

The next general business meeting will be at Yorba Junior High School, in Orange (see attached map), so support your club and bring your Model As and friends to our new location. Also, let's all plan on going to the Round-Table Pizza Restaurant (see map) after the meeting. I visited the Round-Table this week and found it to have excellent, carpeted dining rooms, video games in a separate room, a good menu-salad bar, etc., etc. Also, I have arranged for us to receive a fifteen percent discount, so be sure and tell the cashier, you are with the Model A Club.

Gerry McKinney has planned two tours in February, because it will be six weeks between the January Universal Tour and the Poker Run on February 27. The February 13 tour will be to the Chino Air Museum-picnic-airplane ride. I will be taking a count at the February meeting on how many will be going for a plane ride. P. S.: My flying avocation started in the Marine Corps Air Wine in 1961-65, as a flight simulator instructor (Ling Trainers). During the last four years, I have been checked out in ten different types of aircraft, and I stay quite current in my flying skills.




