

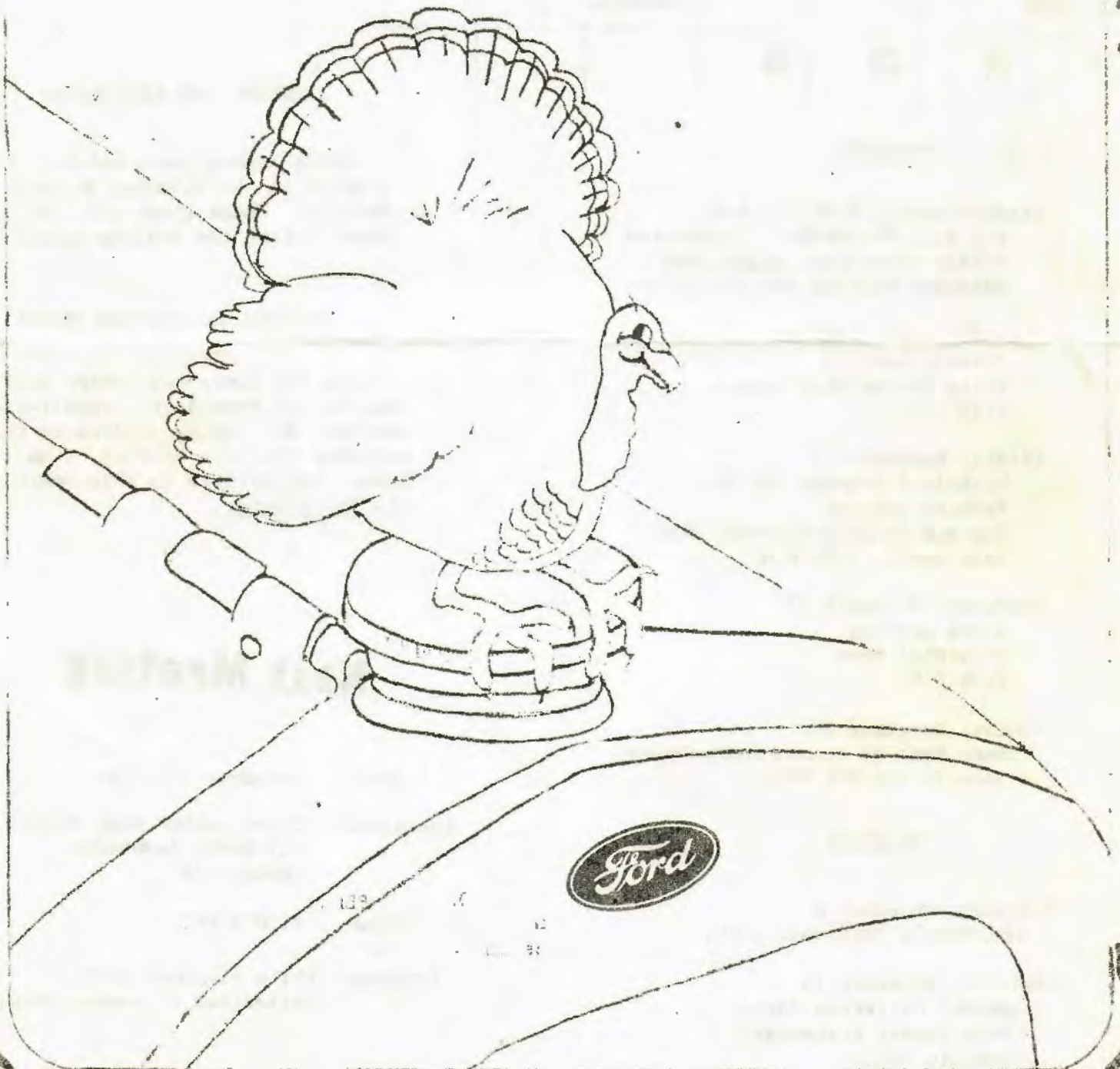

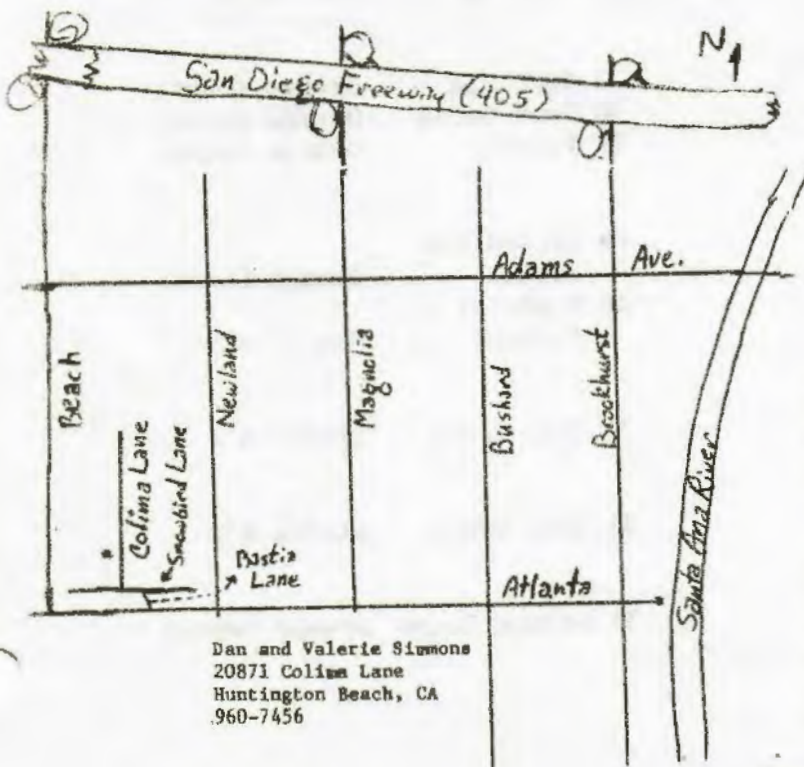
IT'S TIME TO VOTE

ROUNDUP COMMENT

What a terrific Roundup. The weather was perfect. The cars were all beautiful. The costumes were gorgeous. And those raffle prizes were the best I've ever seen at any meet. A super day as usual.

However, at the risk of joining a group I've always referred to as the complainers, I must comment on a situation concerning the modified class at the Roundup. I have always felt that the Roundup was a unique show because of our overall appearance judging of the cars (no lifting the hood, no chassis nit picking, etc., etc.). If overall appearance is to be our standard of judging cars at the Roundup, it seems to me that cars in the modified class should be modified in overall exterior appearance. As any of you who have been involved in judging at the Roundup know, there are always a few cars in the modified class that have C engines, hydraulic brakes, overdrives, or some other internal modification that is not visible on the exterior. I feel that putting these stock appearing cars in the modified class is unfair to both the stockers and the modifieds. My solutions to this problem are to: 1) spell out on the registration form what items qualify a car as modified in Roundup judging, or 2) start judging chassis and engines as part of the car's score, or 3) change the name of that class to EXTERIOR MODIFIED.

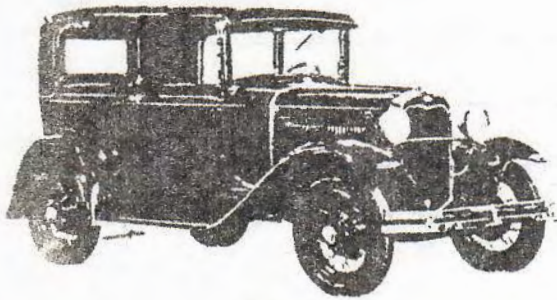
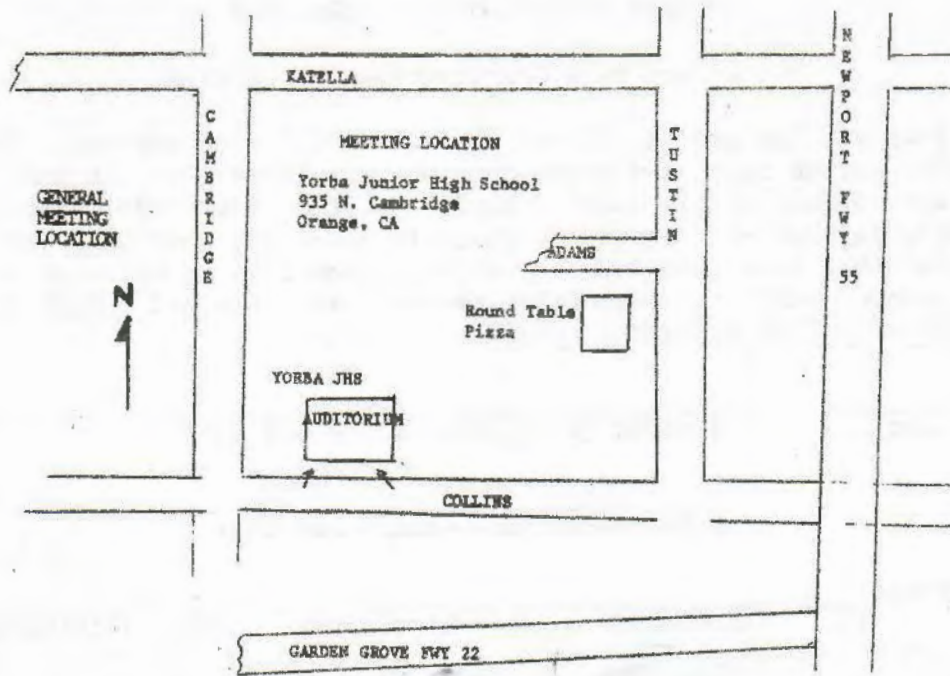

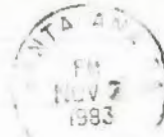
