





- 3 (7 oz) cans whole green chiles
- 1 lb. jack cheese (shredded)
- 1 1b. cheddar cheese (shredded)
- 3 eggs beaten
- 3 tbs. flour
- 1 (5.33 oz) can evaporated milk
- 1 (15 oz) can tomato sauce


Wash chiles, remove seeds, and pat dry. In a 9 x 13 inch pan, layer half the chiles and cheeses. Save 1/4 cup cheese for topping. Repeat layer of chiles and cheeses. Beat eggs, add flour and milk and blend. Pour egg mixture over chile and cheese. Note: Can be refrigerated at this point. Bake at 350°F for 30 minutes. Sp tomato sauce evenly over the tope. Sprinkre reserved cheese on top. Bake 15 minutes more.


