

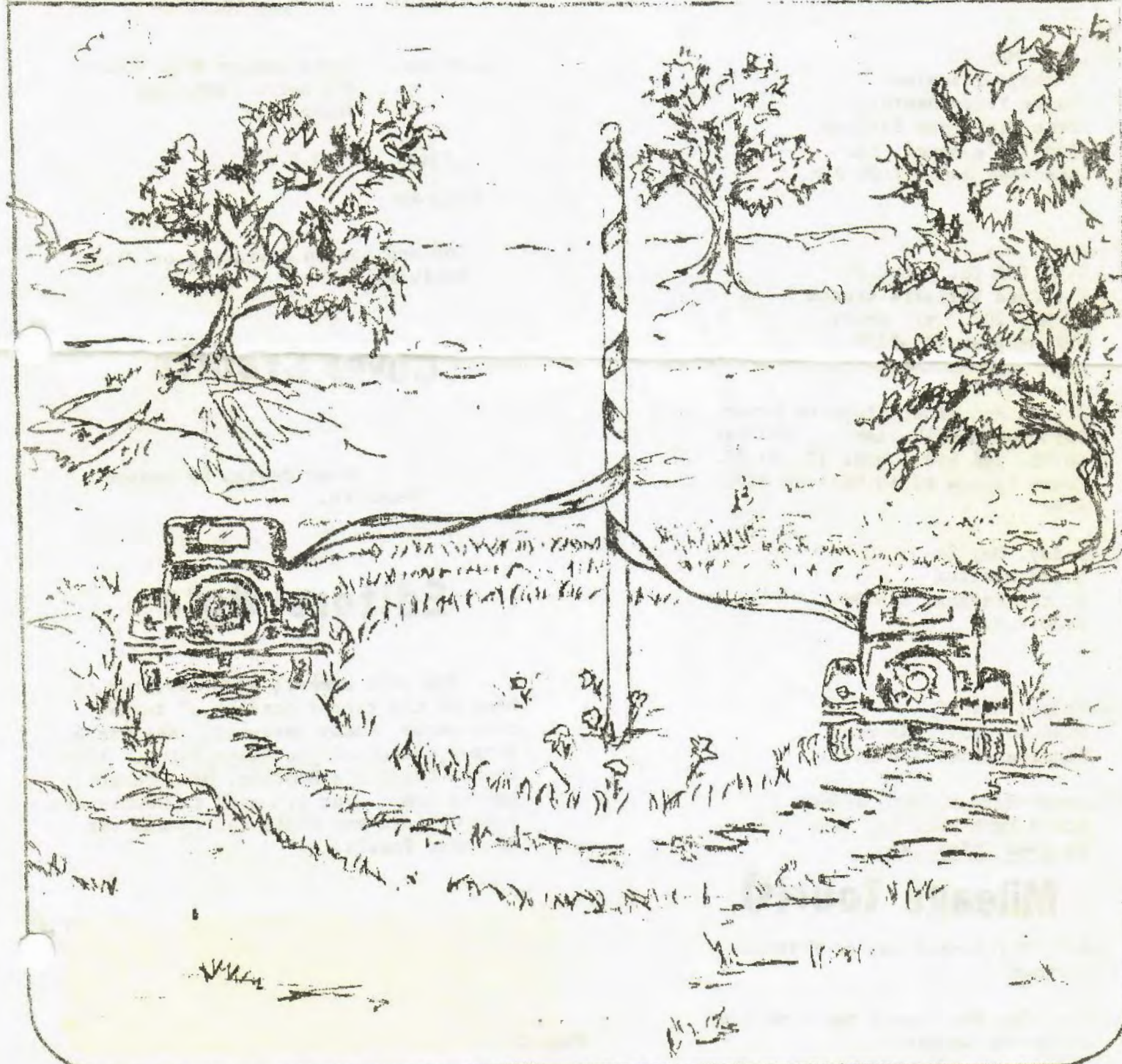

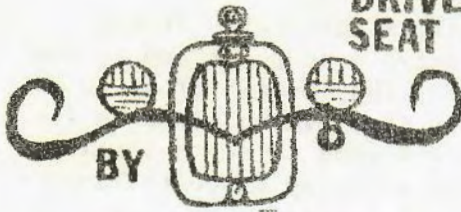

Everyone should mark their calendar for the May 10 Business Meeting to see this outstanding truck. Joe restored it in five months. There were only 158 built and 12+ are still around.

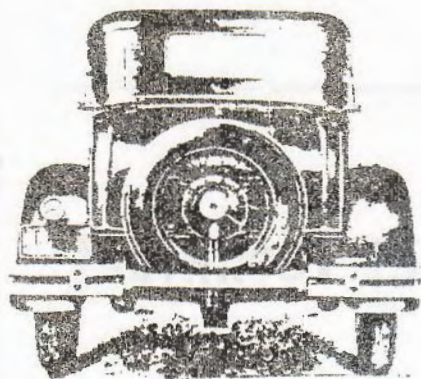

The meeting was adjourned at 9:05 P.M.

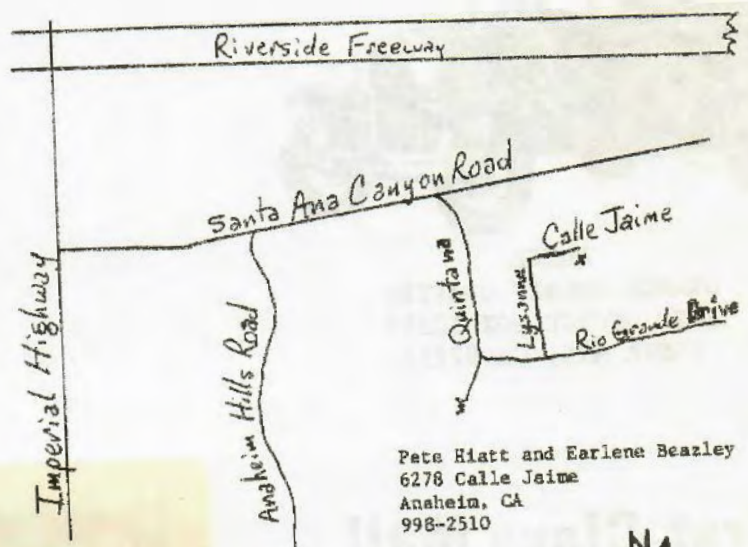

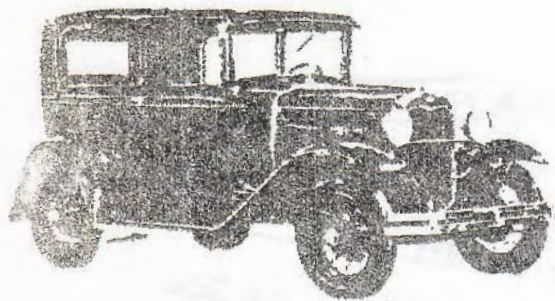
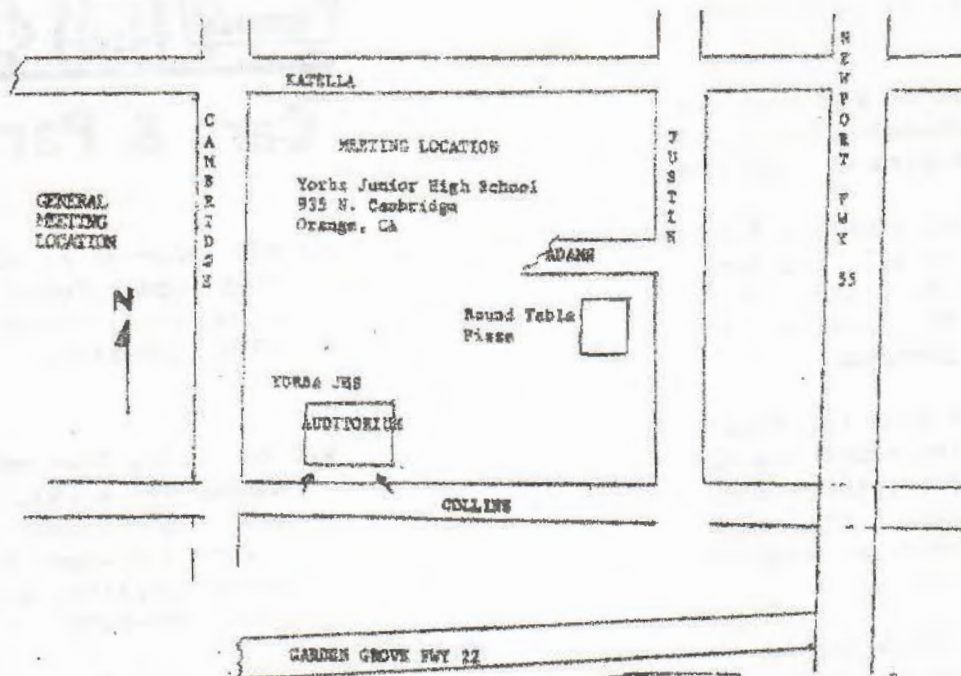
