
DEATH VALLEY TOUR


LET'S GET TECHNICAL

Gruenbeck will try to Pete find an appropriate meeting place for our December Family Christmas party.


Joe Wavra will reservations at W.D. Hart Park for the pancake breakfast for March 11th or the 18th, which ever is available.

The next board meeting will be held at Marsh's home on the 16th of November at 7:30 PM. The meeting was adjourned at 10:15 PM.



OCMAFCA IL Join the Death Valley Tour!

February 16-19 President's Day Weekend

Depart from Orange County Friday morning Return to Crange County Monday evening

- (2) AMARGOSA OPERA HOUSE (K-12; paved road) Performances of ballet and pantomime, featuring many costume changes, are given in this converted movie theater by Marta Becket, a painter and dancer. He productions begin at 8:15 p.m. on Friday, Saturday and Monday, mid-October through April; Saturday only in May and early October. A donation is requested from adults.
- (3) ARTIST DRIVE (J-10; one-way paved road) Oxidation has produced a rainbow of colors in the eroded clay deposits of ancient lakebed sediments. The colors are most intense during the late afternoon. Artists Palette, about halfway along the drive, is a particularly unusual mosaic of red, yellow, orange, green, violet, brown and black hues.
- ASHFORD MILL RUINS (N-10: paved and dirt roads) The fortress-thick concrete walls once housed a mill built in 1915 to process ore from a mine in the Black Mountains. Inefficient operations led to financial and legal difficulties, and the mill closed before its owners were able to realize a profit. Today only the foundations and a tailings pile remain to mark the site.
- BADWATER (K-10: paved road) At 279.8 feet below sea level, this is the lowest point in Death Valley that is accessible by car. Two spots in the salt flats 3.3 and 4.6 miles northwest of Badwater are the lowest elevations in the western hemisphere: 282 feet. The permanent spring-fed pool is not poisonous, although it contains very large amounts of chloride, sodium and suffate. A soft-bodied saltwater snail, found only in the valley, shares the water with beetles and soldier fly larvae. The surrounding area may be the hottest place in the world during the summer months, when temperatures over 120 degrees are typical.
- (28) SCOTTY'S CASTLE (D-6; paved road) Construction of this extravagant mansion in the Spanish-Moorish style began in 1924. The property, formally named Death Valley Ranch, was intended as the winter vacation residence of Albert Johnson, a Chicago insurance millionaire. Its popular name comes from Water Scott, a cowboy, prospector, publicity hound, prevaricator, storyteller and friend of Johnson. Scotty, whose enthusiastic flamboyance was financed by Johnson, managed to convince many that the "castle" was his personal domain.

The house and outbuildings cost at least \$2.5 million; work was never completed. The interior is filled with interesting, well-crafted furnishings and innovative features. The rooms are open to the public only during guided tours, which are given daily from 9 a.m. to 5 p.m. Admission: adults \$4, adults with Golden Age Passport and children 6-12, \$2, children under 6 free. Visitors can take self-guided tours of the surrounding grounds and adjacent structures; the ticket booth sells an informative guide booklet.


- (33) RHYOLITE (E-9: paved road) The town enjoyed an incredible period of prosperity for a few years following a 1904 gold discovery in the nearby Bullfrog Hills. Tents quickly gave way to elaborate stone and wood frame buildings; two railroads were built, along with a stock exchange, hotels, an ice plant, opera house, churches and many other substantial structures. Nearly 6000 people lived in the modern, bustling community. The inevitable crash ended it all, and today there remain only a few imposing stone and concrete ruins, along with the old railroad depot and a restored house originally constructed from 51,000 beer bottles (donation requested). Abandoned mines dot the hillsides, and a weathered cemetery south of town is a symbolic legacy.
- of the few mining towns in the area that actually showed a profit. Only a few scattered ruins remain at the site of a once-thriving community of 700 people who worked the gold mines in the surrounding hills between 1906 and 1917. The residents put up a number of buildings, helped run a telegraph line across Death Valley to Rhyolite, and piped in water 23 miles from a spring in the Panamint Mountains. The town acquired its name because this mileage was the same as the number in a popular saying of the era: "Twenty-Three Skidoo."
- (4) STOVEPIPE WELL (G-7; spur road off SR 190) A rusted, old hand-operated pump marks the location of a waterhole that was important to all pre-automotive travelers in the valley. Old stovepipes were pounded into the sand to form walls for the well.


