Publishers Bob & Karyn Sitter John and Gwen Riggs make the headlines in Mexico. Following is the English translation of an article written in the local Mulege paper (La Extra) about the club's visit to their town:

## Great Caravan of Antique Cars in Mulegé

They will be in the Municipality of Mulegé until Monday and then return to California.

A caravan of 14 automobiles from the beginning of the century, but in excellent maintenance condition, staged a reunion in the municipality of Mulege according to the charming married couple of John Riggs and Gwen Riggs.

We interviewed the couple in front of the Santa Bárbara church where we found these unique original automobiles and we were told they come from Orange, California, arrived as far as the city of Mulegé and will return to their point of origin next Monday.

Among the Ford automobiles, mainly from early in this century, more or less from 1919 several of them but different models, came one automobile that in 1982 went around the world according to the information given us by the married couple.

All of the group, with the treatment they received here, could be magnificent promoters of tourism to our region, as much as these people are very representative of their state (California, USA).

It was explained that one of the group, there were 15, had problems in Guerrero Negro and had to leave their car there but the crew continued with the rest of the caravan arriving in Mulegé yesterday and will stay until Monday in this community.

All of the automobiles are in magnificent highway mechanical condition and each unit could cost much more than a late model luxury car.

In Santa Rosalía they caused a sensation and a good number of the community came close to observe all these museum-collection cars which are still capable of realizing great adventures.



We passed a sign that said, "Winery tours, visitors welcome". Glenn did a quick left turn and we started down a long dirt road until we finally came to some buildings. No one in sight. Finally we found three guys who knew nothing about any tour. We refer to this as our "Non-winery tour."




The La Pinta at San Quintin is a ways out of town and down a rather rough road but what a spot. Miles and miles of deserted beach, soft rolling waves and sand dollars were the view from every room. Glenn and John G. hit the water big time and some of us did the wading bit. It was great. The big "M's" at 6:00 PM and dinner at 7:00. Dinner and breakfast (full American) came with all the La Pinta Hotels.

The 19<sup>th</sup> we were on the road at 9:05. We bought some lunch stuff in El Rosario

the mission was a pile of rocks. What do you expect, it was built in 1769. We did have our lunch stuff so a buffet was spread out on Glenn and Sharon's running board. The owner of the mission was there as well as the green angels, so we all ate together in the little shade we could manage to find. The green angels had found some cactus apples so we had them for dessert.



Our stop for the night was Catavina. Very primitive spot. Boulders and cactus was all you could see. There were only long closed stores and gas statiou. We could get gas via a 7UP bottle and a hose which, a guy sucked to get started. The hotel was fine and we sat and talked around the pool.



The next morning we started early with the idea in mind we would go to Bahia de Los Angeles which was on the Sea of Cortez. Well, it was an 84-mile round trip on the worst paved road we had ever seen. The cars looked like the keystone cops as they swerved back and forth trying to miss the potholes. The beach was beautiful and we ate at a restaurant right on the beach. A good time was had by all. But then it was back on the pothole highway.




When we got back to Highway 1, John G.'s car started to make those usual "I'm a Model A Ford and I'm sick" sounds. It was limp time back to Guerrero Negro where "Hank" was left behind and the Graves joined the Riggs for the rest of the trip. A call to John Knox and he agreed to come and pick us up. (We call him St. Knox).

On the 21<sup>st</sup> we hit a military checkpoint and had to prove we were "distinguished visitors" or we would have to pay \$16 each. It took awhile, but with the help of the green angels and Lee Chase

they were convinced and we finally started across Baja to the east coast. The next night was at San Ignacio. We were there in time for lunch at a restaurant in town, which was very good, then to the hotel where Glenn beat us all at poker.



The next day we reached the Sea of Cortez and came to the rather large town of Santa Rosalía. We drove the cars to the church, which was huilt by Eiffel in Paris and shipped to Santa Rosalía in 1898. As we lined them up, the police started directing traffic around us with their whistles blowing and arms waving. Then, it seemed the whole town came out to see the cars. John and Gwen were interviewed for the newspaper. They were very interested in the engines. I'm sure they thought they would be new engines. We bought some of the best bread you could imagine at a bakery there. It was a wonderful experience. Only 40 miles to Mulegé where we were to stay 3 days. Our hotel, the Serenidad, was far out of town. We got our room key and



were told where it was with a wave of a hand. After a good deal of wandering, we found our room 'Tabasco'. We were right next to the airstrip, but not much activity only private planes. Riggs locked their key in the room and John G. said, "here try ours" and it worked. A quick check of other keys proved they were all the same. So much for security. The Serenidad looked like it had grown like topsy. Not much rhyme or reason to where the buildings were, but a beautiful palm treed spot. The pool was large and beautiful where you could sit at the bar at one end. Sharon and Darlene really got into those Mango Daiquiris in the 8" diameter glass!



On Saturday night was a pig roast and a mariachi band. The place was crowded, but a good time.

On Sunday, we went about 30 miles below Mulegé to a very secluded beach. It was called Requeson and had clear water, no waves and lots of shells. On the way back we had crab quesadillas.

On the 25<sup>th</sup>, we left Mulegé and stopped in Santa Rosalía for breakfast at the French Hotel. We caused another stir in Santa Rosalía.

We then were back in San Ignacio and ate at the same place for lunch. John ordered chicken and we saw a guy come with a chicken in a plastic bag and were sure that was his lunch. That afternoon, Doc took us all at poker! We had no TV in Mulege and the other hotel we had HBO.

Back to Guerrero Negro, it was very cloudy and a little rain. We got to G.N. before noon, but our luggage was on the back of the green angel truck and they were among the missing. In the luggage were the keys to the A. So no chance to look at the engine. The angels arrived at about 8:00 PM. They had a flat tire and had to call the green angels for help. In the afternoon, John and Dorothy Knox arrived. The next morning, the A was loaded onto the Knox's trailer, along with our luggage. So now we were in the comfort of a suburban and on our way back to Catavina. Catavina was still boulders and cactus, but now add windy.

The 28th we just got started when the Johnson's A got an upset stomach. The green angel to the rescue and in about 1/2 hour we were on our way. We stopped at Mama Espinoza's for lunch and that was rip-off city. \$12.50 per person for lunch. It was so called lobster burritos, but it was about three bites of lobster and a tortilla. We arrived at about 9:00 AM at the tourist office and the pictures had been placed on glass plaques etched with the words "Distinguished Visitors" the date and that we were promoting tourism in Baja. As each was presented with their plaque another picture was taken. Quite an event!

Then we were back in Ensenada and said goodbye to the angels and hello to a Travelodge with real television and lots of shopping! The last night was the farewell banquet at a French restaurant and quite upscale.

At 8:45 we were ready to leave Ensenada and getting ready for a stop in Rosarito Beach. The wind was blowing quite hard and was like a Santa Ana. Rosarito Beach was great for shopping, in fact next time we go back I expect a statue to be erected in honor of the Johnson's spending.

It was then time to cross the border. It took awhile, but it was a snap. John and Dorothy towed us to San Clemente where we got a flat bed to bring us up the hill to home.





# Death Valley Revisited



**Information:** Glenn Johnson says it's going to be a good one. Don't miss it!







City Map
