



#### Fouquiera (Idria) columnaris:


The cirio, or 'boojum tree' only grows in a narrow 200-mile-wide band between the 30th and 27th parallels on the Baja peninsula. It may grow to 50 feet in height, and a large cirio may be over 500 years old. It's branches often form bizarre shapes, and the cirio is perhaps the plant most symbolic of Baja.






