


## Day 9: Gwen

He stated that to complete the test I should touch nine (9), zero (0), and the pound sign (#) and then hang up. Luckily, I was suspicious and refused.

Upon contacting the telephone company, I was informed that by pushing 90#, you give the requesting individual full access to your telephone line, which allows them to place long distance telephone calls billed to your home phone number. I was further informed that this scam has been originating from many local jails/prisons. I have also verified this information ith the UCB telecomm, Pacific Bell MCI, Bell Atlantic, GTE and NYNEX. Please beware. DO NOT press 90# for ANYONE. GTE Security Department requested that I share this information with everyone I know.






