

## Dorthy and Harry Murrell

This letter was sent to me; so, I thought I would pass it on to the club since many of the OC club members know Arizona folks.

Dorothy Murrell was killed while her husband Harry was driving their 1929 Tudor home from a long weekend tour down to the Southern Arizona Fall Tour in Yuma, Arizona. The accident occurred 10 miles east of Gila Bend on I-8 on Sunday, October 17, 1999.

Harry & Dorothy were driving their 1929 Tudor in front of a group of 3 As, with Fred & Pat Laurita and Lloyd & JoAnn Green all moving along about 55 mph. A Jeep passed the first 2 cars traveling well over the posted speed of 75 mph & pulled between Fred and Harry. The Jeep basically ran over Harry's vehicle. The Tudor went end over end 2 times and rolled a couple more, Dorothy came out of the passenger door in one of the rolls. The A ended up on its drivers side with Harry still inside. The vehicle landed on Dorothy and she died at the scene. Harry was stuck in the vehicle and Fred who was first on the scene got him out and stopped a leak in the gas tank.

Harry said, "he kept calling for Dorothy but she didn't answer". Fred had to tell him she was gone. As luck would have it 2 paramedics were on the scene about 45 seconds after Fred to assist. Harry was Airevac to St. Joseph's Hospital in Phoenix. He is in the Trauma ICU in stable condition. Fred is a retired police officer from the Denver Police Department.

The group of As had just stopped 10 miles prior to fill with gas and get a snack before heading the last 85 miles home. I have not seen the Tudor but understand that the car will be almost impossible to restore. Funeral arrangements have not been made yet. The people driving the Jeep got out of their vehicle and ran into the desert. The driver has been captured.

Harry and Dorothy have driven the A on many local tours and even to Reno MAFCA National in 1998. They also were attendees in the 1993 & 1997 New Zealand MAFCA Model A Meet. Harry is a past President of the Model A Restorers Club of Arizona and Dorothy very active in the club doing all kinds of jobs. They both have lead tours and were great friends to the Model A clubs & members. Dorothy's last job for the club was to take the dinner tickets Saturday Night at the Banquet in Yuma. Christine & I shared a motor home with Dorothy & Harry when we went to NZ in 1993. That was an interesting experience.

We will miss Dorothy and hope Harry recovers from his injuries. Please put them in your prayers.






