

Ahooga! It's that time again, doesn't seem possible!

#### **August Technical Session**

There was no session scheduled for the month of August; did you miss it? Hope you enjoyed the time off.

#### **September Technical Session**

Doors sagging a bit or hood not lining up? It's been said that a little bit of sagging or leaning is not unusual after 80 years. Well don't despair, it's possible that with a few shims here and there things can be improved. Of course we are talking about a Model A; otherwise we'd have mentioned a Doctor. Anyway, Gerry O'Brien has a Model A with a few of these issues and we will be addressing them on September 22 at his residence in Yorba Linda. The start time will be 8am and the address is: 5340 Los Altos Lane, Yorba Linda, CA.

It is liable to be a bit experimental since we don't have a lot of experience with this but, bring your thoughts and energies and we'll see what we can do. Of course, there will be coffee and donuts and discussion groups; see you there.

#### Technical Clue (for those of us that are clueless)

Have you ever had your head under the hood and wished someone (wife) was nearby to engage the crank to slowly turn the engine over? Let's say you are scraping the carbon off the piston tops or trying to line up the distributor with number 1 at TDC? Well, perhaps the following will help with that.

Pick up a cheap ½ or 12mm 3/8 drive socket at the swap meet or elsewhere. You will also need a 2 inch by 3/16 or ¼ inch roll pin or rod. Drill a matching hole through the socket roughly in the center of the length and insert the pin (see the photo below). The pin should be a tight fit or peened so-as not to slide out. Now, by fitting the socket to your handy 3/8- drive ratchet you have a substitute for the engine-crank and can use it under the hood (see photos). Now doesn't that just make your day?

## Bonny & Clyde!

#### **Fact & Fiction**

Most people living today have a conception of the life and times of Bonny Parker and Clyde Barrow based on the 1967 Hollywood movie "Bonny & Clyde". The movie starred Warren Beatty and Faye Dunaway. Both actors were tall and beautiful; the real Bonny & Clyde were anything but that. Their two-year reign of terror was depicted as adventurous, when in fact they endured a dreary, painful existence until they were finally put out of their misery. The movie is good entertainment, but certainly not factual. The ambush scene comes the closest to the actual truth.

A third character in the movie was that of C. W. Moss (played by Michael J. Pollard), a somewhat goofy teenager cast as part of the Barrow gang. The character is fictional and was a melding of two factual people who were members of the gang at different times. The first was W. D. Jones, just 16-years old when he joined the gang. The second was Henry Methvin, a hardened criminal in his early 20's. It was Methvin's father who in fact set up Bonny & Clyde for the ambush in return for a pardon for his son Henry. Today there is an antique auto parts store in the City of Orange in Southern California that goes by the name C. W. Moss.

The 1934 V8 Ford Bonny & Clyde were ambushed in is still around. The car was stolen from Ruth Warren of Topeka, Kansas on April 29, 1934. After the ambush Ms. Warren filed a Federal lawsuit to regain custody of the car. She eventually sold it to Charles W. Stanley who toured the country with it until the early 1950's. Today the car is on display at a gambling casino at Stateline, Nevada.

The ambush took place on May 23, 1934 outside of the small town of Gibsland, Louisiana. Today the town thrives on a Bonny & Clyde tourist industry. Six law enforcement officers lay in wait on a lonely road. The disabled truck of Henry Methvin's father was set up as a decoy along the road. When Clyde Barrow stopped to offer assistance the officers opened up with a barrage from high-powered automatic riles, including several BAR's. They were no more than 30 feet away. The first burst hit Clyde in the head and he was killed instantly. All six officers continued pouring fire into the vehicle and essentially shot the occupants to pieces. Texas Ranger Frank Hamer, the officer in charge, walked around to the

passenger side of car and fired several more rounds point blank into Bonny's lifeless body. He could clearly see that Clyde was already dead.

Henry Methvin was given a pardon by the states of Texas and Louisiana as promised. However, the state of Oklahoma had made no such agreement. Henry was extradited to Oklahoma and convicted of murder and sentenced to death. The sentence was later commuted to life in prison and he was paroled after 8 years. He was shot to death some years later.

Articles written about Bonny & Clyde during their life, and for a number of years after, were in many cases exaggerated, contained inaccuracies, and in some cases downright untrue. Even articles written later by surviving family members are suspect, as many of them were covering their own involvement in harboring the two fugitives. Clyde Barrow is said to have murdered more than a dozen people.

A recent book, "Go Down Together" by Jeff Guinn, published in 2009, is a well-documented and factual book about the true existence of Bonny & Clyde. (IBSN-13: 978-1-4165-5706-7) ©

We can't attest to the details of engagement but, he asked and she accepted. The engagement was to last about 16 hours with the wedding party assembling on top of Davis Dam only inches inside the state of Arizona where the minister was to perform the nuptials.

The minister dramatically arrived in a small motor home adorned with the prophetic words "Matrimony- mobile". From inside immerged the reverend lady minister who reunited the two as one. It was a beautiful day in the great outdoors spanning two states.

Laughlin will forever be remembered as a happy moment of reunion and love in the clubs history. I'm sure you will agree that: This was the best "dam wedding", ever.

*Prolog:* A lot of water has flowed over the dam. Paul is retired. Diane will do so at the end of this school year. Alison is an accomplished scholar and college graduate.

Paul and Diane have bought a house on "the big island" in Hawaii.


#### **OPPORTUNITY TO SERVE!**





In the fall, the apron was used to bring in apples that had fallen from the trees.

When unexpected company drove up the road, it was surprising how much furniture that old apron could dust in a matter of seconds.

When dinner was ready, Grandma walked out onto the porch, waved her apron, and the men knew it was time to come in from the fields to dinner.


