

Ahooga! Ahooga! Let's get technical

September Technical Session

Well, we did it. We met on Tuesday morning at Gerry O'Brien's home in Yorba Linda. Did not have a big crowd; Myself, Gerry, Frank Mower, Bob Jefferies and Curtis Buck made up the attendees. Gerry has a 1929 Model A Coupe that had issues with the door alignment. To establish a reliable baseline, we first replaced all the rubber pads (shims) between the body and frame. At this point additional shims were placed using a "trial and error" sequence of assembly repetitions. At the end of the session we had reduced the alignment errors by about 50%.

Curtis Buck brought his 1930 4-door sedan having issues with the fit of the windshield to the body. The problem was that the windshield rubbed against the cowl at the right side. It was discovered that the windshield frame was not adequately fastened to the body header and in addition the windshield glass was not fully seated within the frame, resulting in a longer edge at the right side. We were able to correct the attachment at the frame header however, the windshield frame and glass need to be disassembled and have new seating material installed. As always, coffee and donut disposal activities went well.

October Technical Session

Well, I've had a couple inquires concerning front end alignments and tie rod ball joints, etc. Perhaps it is a good time to arrange to put the cars up on a hoist and do a front end inspection and a look-see about the general vehicle safety. John Knox has volunteered his hoist and yard for Saturday, the 24th of October beginning at 9am. John's address is: 1146 N. Puente St. Brea, CA

We'll make it open to general problem solving with a focus on safety if that sounds good to you model A'ers. See you there.

Technical Clue (for those of us that are clueless)

This month's clue is taken from the Sept, 2009 newsletter published by the Old Dominion Model A Club of Virginia.

The article is summarized herein and concerns the benefits of the Model A Engine Pans. If you are not familiar with engine pans they are the formed sheet metal parts mounted on both sides of your engine between the engine and the vehicle frame. They mount on two oil pan bolts on the each side of the engine and three bolts through the frame. The benefits derived from having the pans installed are the following: First, they serve to keep road dirt thrown up by your front tires from entering your engine compartment and being drawn into the carburetor. Second, they serve as an electrical grounding path between the engine and frame and are therefore an important part of the vehicles electrical system. Third, they actually improve air flow through the engine compartment thus improving the efficiency of the radiator.

Besides the above benefits, you will find that they make your engine compartment appear finished. They also provide a path for coolant drained from the petcock on the driver's side into a container placed at the pan's rear edge.

If you do not have these pans on your vehicle you should seriously consider installing them. After-market pans, are available from most Model A part suppliers.


