Election Time

Model A Electrical System:

A classroom type seminar will be presented at the CHOC hospital on **Saturday, October 16, 2010 8:30 AM to 1:00 PM.** The subject will be the Model A electrical system and will be presented by Tom Endy. Several of our neighboring Model A clubs have been invited to attend the seminar. The presentation will specifically take into consideration people who do not have a background in electrical technology.

Handouts of the Model A electrical system will be provided. There will also be a dynamic display device presented that operates from a 6-volt power source that has a Model A coil, condenser, and spark plug. The display visually fires the spark plug such as would an engine operating at 1,000 RPM.

The seminar will cover all aspects of the electrical system including the battery circuit, the generator and cut-out circuit, the light circuit, horn circuit, and the ignition circuit. It will also cover 6-volt to 12-volt conversion.

Emphasis will be placed on the several peculiarities of Henry Ford's unique electrical system and some of the side effects caused by modern electrical system modifications available to hobbyist today.





IT'S A REAL STRETCH



Can you TOP this? In the continuing ownership of a Model A, that question is bound to come up and while the answers very, they are all stretched! Now Rick Hall has recently become aware that the next step in his Victoria restoration project was the installation of a top. Toward this end he enlisted the help of Wayne Wiedle and together they were able to "stretch" the project out a bit. Of course every project needs a gallery of bystanders which are able to provide endless suggestions for improvements. This function was readily provided by Bob Jefferies, Don Ratzlaff and Dom Cimarusti. All in all, the project went well and Rick's Vicky should be good in the rain on future tours.



Technical clue for those of us that are clueless. (By Don Ratzlaff)

Alright, for some reason you want to look under the hood on your Model A. To do so you unlatch the hood fasteners and manage to raise it up and prop it on the cowl webbing (relying on friction to hold it in place). Now you decide to start up the motor and the engine vibration causes the hood to slip and come violently down to a closed position. By taking a short piece of $3/8^{th}$ rubber hose, slit to accommodate sliding onto the rolled edge of the hood, as shown in the photo below, the problem of "hood collapse" is eliminated. In addition, if a second piece of rubber hose is added, they will function as anti-rattle bumpers for the hood latches, see the second photo.

The Rear End Saga

The MAFCA 2010 national meet was held this past August in Vancouver, British Columbia, Canada. It was my great pleasure to be able to attend. During any of these meets a number of cars usually come into the repair tent at the hotel in need of serious repair. I am always curious about Model A mechanical and electrical failures so I tend to drift past the repair tent each day to view the casualties.

One such car came in with the differential in trouble. The owner of the car was from Kansas and had driven his 31 coupe pulling a small trailer the entire distance of about 2,000 miles. He was traveling with a group of five other Model A's. About half way to the meet he heard a loud clunk coming from the rear end, but the car seemed to be moving ahead with no problem so they continued. About 20 miles from Vancouver there was a second loud clunk and the rear end locked up. The car was then brought to the repair tent by Triple A.

The first day I saw the car I noticed the owner and his Kansas buddies were in the process of pulling the rear end. They had a spring spreader obtained from the repair tent and were unhooking the shackles. They seemed to know what they were doing and were going about it in a safe manner. I thought it prudent not to bother them so I moved on.

The second day I drifted by and saw the rear end was out of the car and for some reason they had also removed the spring spreader and the spring itself. It seemed like additional work to me. I also noticed that the car did not have an overdrive or a four speed transmission. I still deemed it prudent to not comment, so I moved on.

The third day I drifted by and all progress seemed to have ceased. Several people I knew commented to me that the owner was in a dilemma and needed some assistance. He had no idea what was wrong with the rear end and was afraid to take it apart. One of the Vancouver hosts offered to sell him a complete rear end (of dubious condition) for \$2,500 (exchange). This seemed a little much to me. Another local offered to sell him a new 354 ring & pinion gear

set he had just recently bought from Snyder's for the same price he had paid for it.

This was certainly a reasonable and generous offer. However, the owner of the 31 coupe did not know how to go about installing it, and no one was offering to provide guidance. A new ring & pinion gear set currently sells for about \$500. Two years ago they sold for about \$250 until all the suppliers collectively doubled the price. Still, \$500 was better than \$2,500.

Several people I knew asked me to talk to the owner. I approached him and told him I have a cottage industry and have rebuilt more than 200 rear ends in the past 20 years. I suggested we disassemble the rear end and see what was going on inside. When we got it apart we found two teeth busted off the pinion gear and some collateral damage to the ring gear. I suspect the first clunk that was heard was the first tooth breaking off the pinion. The tooth apparently went quietly to sleep somewhere inside the banjo until the owner may have hit a bump and it woke up and jumped up and broke the second tooth off and jammed the rear end. Everything else inside the rear end looked reasonably serviceable. I suggested to the owner that he buy the offered ring & pinion set as I was certain I could get him back on the road again.

The owner was still in a dilemma as he did not know me, and for all he knew I was blowing a lot of hot air. Someone mentioned the \$2500 rear end had showed up at the hotel. However, I never did see it. The local who had the ring & pinion was busy judging cars and could not break free for several hours to go home and get it.

At this point I told the owner I was going to lunch and would stop back later and if he decided on the ring & pinion I would install it for him. While I was gone several people stopped by, including Art Moore and Marlin Perry, and told the owner to go with the ring & pinion and to trust me as I knew what I was talking about. It was a very nice compliment from both of them.

When I came back after lunch the owner had decided on the ring & pinion, however we would have to wait several more hours before it would arrive. With that decision made a massive clean up project was organized and the owner and all his Kansas buddies jumped in to help. We had

to clean out a lot of metal debris from inside the housings.

I noted two disturbing things I could not do anything about due to the nature of a pepper tree repair we were doing. One of the carrier bearings had spun on the carrier hub. Normally I would exchange the carrier for one that had been knurled. The other was severe wear to the bearing hub on one of the axle housings. There was easily 1\16" of wear off the bottom of the hub. This may have been a contributing factor to the ring & pinion failure. There was nothing I could do about that either. A replacement axle housing or a repair to the hub was not available under the circumstance.

Fortunately everything came apart without difficulty. The repair tent had a set of pinion wrenches and a section of pipe used for installing bearings. The only show stopper was the need to get the bottom bearing off the damaged pinion gear sleeve. A bearing puller and a press were needed and the repair tent had neither. A local Vancouverian was standing by observing and said he had both at home and offered to pull the bearing for us. Certainly a life saver and very generous. He was back within an hour with the removed bearing.

Later in the day the new ring & pinion appeared and the owner was pleased that it was a 354 ratio. The damaged set we removed was a 378. It was now time to proceed with the assembly. There had been ample time for us to clean up all the parts. We were under a shaded tent and there was a work bench with a vice attached. From here on it was a piece of cake to reassemble the differential.

I noticed that a number of people began showing up and were pulling up chairs to watch. A number of them had cameras and were taking pictures. A full blown seminar was in progress. Several prominent people including Mark Schwing and Steve Mitchell (of Mitchell overdrive fame) jumped in to help. Long before dark we had the rear end assembled. This was about where I came in. They did not need me anymore, so I left. The Kansas folks started installing the backing plates and by dark they had the full up rear end ready to go back in the car.

Early the next morning the Kansas folks had the rear end installed and were buttoning up the floor boards and putting the back wheels on when I stopped by. I advised the owner, his

name was Frank, that when he got home he should pull the rear end apart again and replace or repair both the carrier and the worn axle housing. He should also install a new set of bearings and seals and set all the pre-loads properly. He would know how to do it now since he had been through two thirds of the process. The rest he can get from the tutorial that is posted in the technical section on the Orange County web site (www.ocmafc.org).

I had to leave before they had finished with the car as we were going on the traditional "grand tour". When we got back in the afternoon the 31 coupe was gone. I spoke with the repair tent custodian and he told me the car ran just fine and the owner was extremely pleased. I did not see any of the Kansas folks again as they were staying at a different hotel and they left the next morning.

The owner called me after we got back home and advised they all made it back to Kansas without a problem. It is always a good feeling when you can help another Model A'er who is having difficulty.

Fortunately for myself, I had no serious difficulty with my Model A. We drove the Victoria from home to Vancouver and back without a problem. I used about a pint of water and no oil. I did change the oil and filter while in Vancouver.

The two minor problems I had with the Victoria were that the ahooguh horn stopped ahooguhing about half way to Vancouver. I like to ahooguh all the cows I see alongside the road. They get funny looks on their faces. I believe they think the bull is coming back. At the next gas stop I adjusted the horn screw and the ahooguh returned to fine form. The last night of the return trip we stayed in Ridgecrest. The next morning I went to start the car and the Bendix jammed. I put the transmission in gear and rocked the car back and forth and the Bendix released.

We participated with John LaVoy's Model A Times tour group and traveled to the meet on Highway 101. We actually traveled with three other Model A's from the Palomar club, John & Dianne Frazee, Howard & Barbara Kruegel, and Bruce Howe & Jeannette Smith. On the trip home we traveled by ourselves as our traveling companions all went on the Alaska cruise. We came home on Highway 395 from Susanville. Our total mileage was 2,931 miles. We cruised between 55-60 mph, used about 165 gallons of gas, and averaged 17.5 mpg.


