

## Jim's Tech Tip—Installing a New Fuel Line

When installing a new fuel line between the sediment bowl and the carburetor, you want to get the little brass ferrule locked down on the tubing about 1/8" from the end of the tubing. It is difficult to see where the ferrule is located on the tubing, though, when the end is inside the carburetor or the sediment bowl. Here's my little trick to getting it where you want it.

On the bench, before installing anything on the car, slip the tube nut and ferrule on the end of the fuel line like it will be installed on the car. See the photo. Place the ferrule on the tubing with 1/8" of tubing showing on the end. Gently press the nut up against the ferrule and mark that location with a little piece of masking tape.



Now when you install the tubing on the carburetor or sediment bowl, you hold the tubing in so that the tape is right at the edge of the nut while you tighten the nut. When the ferrule gets clamped down on the tubing, it will be in the right spot. You can take it apart to check.

I apply a few drops of oil to the threads of the nut and to the ferrule when tightening it

all up for the first time, to help everything turn smoothly as it's being clamped in place. Teflon tape should not be needed on these tube nuts and ferrules; they are designed to seal with just the nut being tightened. It does not hurt to put a thin film on non-hardening sealant on the ferrule, though, before installing, for extra protection against weeping fuel.

I hope this helps the installation of your next fuel line easier. Have a Model A Day! Jim



## Is That a Crack in Your Engine Block? Or Do You Just Have a Blown Head Gasket?

Ever have the experience of checking your oil and notice a milkshake-like color? Or have you opened up the radiator cap and noticed bubbles coming up but your car's not overheating, or maybe an exhaust/fuel smell from the radiator as you watch the bubbles boil from under the baffle? Chances are you may have a crack in the block. But how do you tell for sure? I've had both of these situations happen in the last couple of years. I didn't want to contaminate my new radiator core with more bars leaks. I finally bit the bullet and purchased an engine leak testing kit from Snyder's. It comes complete with a metal plate and a rubber gasket that bolts down to the block, and an adjustable air valve to control the air pressure. You just put on your preferred air connection fitting and you are good to go.

You start by removing the head and cleaning the deck of the engine block. The test plate has to make a good seal to be effective. Remove the water inlet fitting from the side of the block and connect the air regulator with the supplied plate.

Bolt on the test plate to the block deck, rubber side down, careful not to over torgue and distort the rubber. What you will be doing when you attach the air hose is pressurizing the water passages in the block with 40-50 psi of air. Using a small brush and soapy water start wetting down the suspect areas of the block. Areas around the valves and between the cylinders, near exhaust ports. You may have noticed rusty areas near these points. Those would be a good places to look. Also check areas of the water jacket outside the block. If you see bubbles, you've found a crack.

When I hooked the air up to my assembly I was a little surprised at the annoying hiss of air coming from the block. My first thought was, "OMG the engine is ruined!" Nope, just needed to tighten down the test plate a bit. The seal has to be tight all the way around.

Once the test plate was tightened down, I reconnected the air hose. Aaaand nothing. Pretty anti-climactic. No air leaks, no bubbles anywhere. Well that's a good sign. Much to my relief there didn't seem to be any cracks in the engine block. At least none that I could detect using the tester.

So how is the water getting in the oil, and where is the air coming from that bubbles into the radiator? The only explanation left is the head, and head gasket. I didn't notice anything remarkable about the head gasket when I removed it. No tell-tale signs of failure or deformation. Well that leaves only the head. Is the head warped or cracked? I'll have to check it with a straight edge. Well, not a problem. I just happen to have a spare. After reinstalling the new head with a new head gasket, I'm happy to report I've been motoring around with no problem. No more milkshake oil and no air bubbles from the radiator. I have yet to really investigate the head I removed, but a quick inspection didn't turn up any visible cracks.

If you are confident there are no cracks in the head, you can have it milled flat so it has a perfect mating surface to the block. Also keep in mind, any imperfections in the head or the block deck can be points of failure for the head gasket to seal.

The block leak test kit was a huge help in ruling out a more catastrophic end and was worth the time and money. Keep 'em running and enjoy the drive.

### Le Barron Bonney Update

Many of you know LeBarron Bonney as a staple in the Model "A" hobby for providing high quality parts, materials, upholstery and top kits. The company declared bankruptcy and went out of business over a year ago, leaving a large hole in the restoration supply chain. However, a report in t he May 21, 2020 issue of Old Cars Magazine stated that "the entire upholstery inventory was legally transferred to Eckler Industries Inc. effective Dec. 19.2019."

Ecklers is a large catalogue auto parts company that provides a wide range of Chevrolet parts, and owns MAC's Antique Auto Parts, providing Model "T", Model "A" and V-8 Ford parts. Ecklers can be reached at 800-284-3906 or email at custsys@ecklers.net.

### Doris Day's 1930 Ford Model A Roadster sells for \$96k

Nearly one year after Doris Day's death, her fans made sure she'll never be forgotten, gobbling up items

owned by the Hollywood legend, singer, and animal rights activist. In a weekend estate auction hosted by Julien's, fans of "America's Sweetheart" placed online bids for more than 1100 items from her residence in Carmel-by-the-Sea, California, known as "Overlook."

Day died of complications from pneumonia on May 13, 2019. Day would have celebrated her 98th birthday on April 3.

Julien's said that the auction generated more than \$3 million, far exceeding presale estimates of \$300,000–\$600,000. All proceeds benefit the Doris Day Animal Foundation (www.ddaf.org).





Topping the list of items sold was Day's <u>1930 Ford</u> <u>Model A</u>, which she owned for more than 35 years and was frequently seen driving around Carmel. The rumble-seat roadster, which Day nicknamed "Buttercup," sold for \$96,000, more than nine times its estimate of \$10,000.

The car was a gift from a fan and Day had it restored in the early 1980s. It is powered by a 40-horsepower Lhead 200.5-cubic-inch four-cylinder engine, mated to an unsynchronized three-speed manual transmission. Among the Model A's features are dual running boards, front and rear bumper guards, side and review mirrors,

rumble seat, mounted spare tire, wire wheels, and fourwheel mechanical drum brakes. The odometer reads 35,142 miles.

Included is Day's personalized license plate "I Bixby," a reference to her nickname, "Clara Bixby," given to her by good friend Billy De Wolfe decades before. It also has written starting and shut-off instructions taped to the dash. Editor's Note: An interesting side note, our newest member, Janet Walker-Polito, is the current proud owner of Doris Day's Model A.






